

ANNADA

Climate Smart Agriculture

Funded by KFW -NABARD & EDELGIVE

Operational Area-Jashipur Block, Mayurbhanj, reamal block, Debagarha

ANNADA is about addressing the climate change effects and making rural farmers adaptable to the changes caused due to Global Warming through Integrated Watershed Management and promotion of CSA (Climate Smart Agriculture) and CSV (Climate Smart Village) to enhance the productivity and raise income.

Climate change causes heat stress, which depletes groundwater resources and increases saline contamination of soils inland. Soil salinization decreases crop productivity. Locally, many farmers are seeing lower yields, which results in less income generation

CSA is premised on three main principles. These include:

- (1) Addressing climate-related risk while improving food, income and or nutrition security;
- (2) Achieving productivity and livelihood benefits;
- (3) Having area-specific technologies that suit the specific areas in which they are practiced.

Where possible, CSA also aims to reduce greenhouse gas (GHG)



emissions mainly through enhancing the carbon sink (vegetative cover). We provide training to farmers (both men and women) on CSA techniques and practices in the context of local agricultural practices and demonstrations. It covers 4 watershed program covering 2491 Hectares in and around similipal bio-sphere, Mayurbhanj District two watershed program covering 1500 Hectares in Deogarh District.



Raicharan Singh is a marginal farmer age about 30 having 4 family members from Chardipahadi village. He has only 2 acres of land from which one acre is purely upland. He used to cultivate paddy only in Kharif season 1.5 acres & another 0.5 acre remains barren for years. It is very difficult for him to manage his family from agriculture.

A powerful message from Raicharan Singh

Through this project we have motivated and persuaded him for small scale commercial vegetable cultivation and he also agreed & he developed 0.5 acre of upland and started cultivating in last Rabi. We supported him improved variety of seeds, micronutrient and trained him on preparation of organic manure. In last season he had cultivated Tomato in systematic manner. He has given his effort to produce good crops and as a result he also succeeded. In last season Raicharan sold more than Rs.40,000/- of Tomato crops. With this money he has expanded his land and purchased a diesel pump set for irrigation. Raicharan also started cultivating radish, Cow pea & ridge gourd in his land in this season with his own effort. This can help him to maintain his family in a good condition.

ARANYANI

Sustainable livelihood through farm & nonfarm activities

Funded by OTELP, ICRISAT

Operational Area- Jashipur Block, Mayurbhanj

Thakurmunda, Mayurbhanj

ARANYANI is an initiative towards the sustainable livelihood of rural community through some income generation activities (farm & nonfarm activities). e.g. saal leaf plate making, Tamarind Cake Making, Processing and Selling of Honey, Kusum, Neem, Karanj Oil Processing, Non timber forest products, Mahua Seeds, flowers, Char Seeds, Soaps, Herbal Medicines and products, etc. In total 48no of SHGs member are engaged in the above mentioned sustainable livelihood actives.



A Ray of Hope

In the programme of aranyani , here is a successful story where a women is producing poultry feeds and selling the feeds. It is a income generation activity for her.

Few years back , she was unable to feed her family properly . being a women she has faced discrimination and disparity at the hands of her husband.

With the help of the project funded by OTELP and ICRISAT , she is now an important earning member of her family and has been involved proactively in various other income generating activities. The most important aspect is that she has been enrolled her children in schools and she is now a decision maker in her family.

The programme has helped her in empowering her life which has brought forth a ray of hope .

ADHARSILA

Livelihood through livestock

Funded by Heifer International

Operational Area-Thakurmunda Block, Mayurbhanj

ADHARSILA focuses on the enhancement of the livelihood of rural communities through livestock which can actually increase survivability of poor people having access to livestock, to a significant extent. The livelihoods we have directly promoted with women and communities through improved animal husbandry (like goats, backyard poultry). In this program we are working in two blocks of Mayurbhanj (i.e. Thakurmunda and Jashipur) and engaging with more than 7500 women organized into 635 SHGs.



Poultry has been a source of livelihood since time immemorial. sambandh focuses on the very basic needs of life for upliftment of livelihood.

Poultry is sustainable and a feasible option for enhancing life .



At the end Its Happiness

As we all know women are always at the most vulnerable junction of life , whether be it family or in the outside world , it is women who have faced various problems at every phase of their lives . Here we bring forth a success story of a woman named "kamala" , who has struggled enormous days for her happiness . kamala got married at the age of 15. She has 3 children..unfortunately few years back , her husband dies and she is left with her 3 children and her mother in law. Kamal always had the spirit of earning for her family and setting up her own business . she always wanted to be an entrepreneur. Sambandh along with Heifer international took up the challenge of securing kamala's life both economically and socially. Now kamala earns her livelihood through livestock. She has been provided with a small poultry house where she has kept chickens and she is looking after them , both feeding and vaccinating them . she has been earning in thousands now and has been able to enroll her children in schools . kamala as well is taking care of her mother in law. Kamala's struggle and her hardwork has finally paid off.

APURBA

Sustainable Bio-diversity Business

Funded by: OTELP, NABARD

Focuses on enhancing livelihood of small producers through federation of producer groups and Farmers producer's company. In order to serve the need of aggregation, sharing services and absorbing price risks we have formed four farmer producers organization, Five of SHG Federations and 142 groups in our project areas.



SHG federation is a powerful group of any village. In india the very concept of SHG has garnered a lot of success. Sambandh has one of the most pioneer activity of forming women SHG s at the village level . we understand that women are better decision makers and when in a group , they support each other at times of need.



Ginger to the rescue

There are many women farmers in our country but they are rarely into any high end business. Such is one story of rebati majhi who is a women farmer . she cultivates a number of crops but ginger has been her game changer.

In the program of apurba which is funded by otelp and nabard , and in collaboration with Sambandh , rebati majhi was provided help and she took the opportunity to cultivate ginger and sell fresh gingers along with other output . she has been part of a SHG federation and it has even helped her at times of her need.

She has secured her child's education .she is now a confident women who has been taking proper future decisions , be it education , social security and health.

ABHIJAN

Campaign for nutritional wellbeing.

Funded by OTELP, ICRISAT

Operational Area-Jashipur Block, Mayurbhanj

Rani is a women farmer of Mayurbhanj . with Sambandh's help , rani has been able to grow various crops which has helped her in including various proteins and vitamins in her daily diet. She has been an inspiration for her village . ABHIJAN focuses on nutritional education with Sustainable agricultural practices in the remote areas of Odisha. This offers each individual to learn about essential of nutrition for health and to take steps to improve quality of their food Consumption pattern. It promotes nutrition sensitive agricultural practices by diversified crop management technique in order to optimize the use of nutrients in the soil and also minimize the pests.Crop diversification is practiced in rain fed lands to reduce the risk factor of crop failures due to drought or less rains. Crop substitution and shift are also taking place in the areas with distinct soil problems. For example, the growing of rice in high water table areas replacing oilseeds, pulses and cotton; promotion of soybean in place of sorghum in vertisols (medium and deep black soils) etc. Vegetable clusters are emerging as the major alternatives as cropping pattern changes .

Since the beginning of mankind , human beings have been very curious about the food they eat.with the advent of science and technology ,the very curiosity of knowing about the food has garnered much of attention .but somehow ,there is also another side to the story.Due to low levels of education , people have become unaware of the food they eat. Not just low education , but also a sense of ignorance and poverty has pushed half of the population to such levels that they do not know as to which food should be consumed and what is a balanced diet.The very need of the hour for the country is generation of proper and efficient human resources and that is possible only through proper balanced diet. It is only when a person eats right ,will he be able to take better decisions in life.

ANANYA

Women entrepreneurship through SHGs

Funded by OTELP, ICRISAT, PPL

Operational Area- Jashipur Block, Mayurbhanj

Kujanga Block, Jagatsinghpur

ANANYA is an initiative of Women entrepreneurship development program which focuses on for holistic development of women through entrepreneurship and various sustainable livelihood income generating activities like honey collection, processing and sale, including that of herbal medicines, Mushroom cultivation etc. The main purpose is to strengthen the women and make a sustaining SHG



Here is another story of a woman named Durga. Sambandh has been very keen about traditional healing medicines since its inception. One of Sambandh's major work was Arogyam program where it focused on various methods of traditional healing.

Durga has a great knowledge on various medicinal plants in Jashipur. She herself used to prepare various concoctions and heal her village people. Through the Ananya initiative, Sambandh helped Durga in marketing her medicines to the outskirts of her village, where she earned a sustainable amount of money to earn her living and for her child's education.



Sambandh through its women entrepreneurship program has helped a number of women in realizing their dreams. One such success story is of Jhumki who is a young woman in her 20s. She was married at the age of 13. She always wanted to do her own business. Sambandh with the help of OTELP, ICRISAT AND PPL have helped Jhumki in setting up her own business of mushroom cultivation.

She has been very sincere in her work and her hard work has paid her off. She is now a well-known person in her village. People respect her as she is the earning member of her house. With the money that she has incurred through mushroom cultivation, she has been able to do her father's treatment. She has achieved one of her dreams and there are many more to go.

ASHA

Renewable energy for mitigating global warming and reducing Carbon emission.

Funded by: PPL, EDELGIVE

Operational Area-Kujanga Block, Jagatsinghpur

Jashipur Block, Mayurbhanj

This program promotes renewable energy in rural area and attempts to mitigate climate change and global warming issues by reducing carbon emissions for livelihood sustainability. And it also provides knowledge and skills to the community to adapt various climate change measures.

Solar Irrigation system has been promoted and solar pump set has been introduced in 9 Villages which are really helpful for the farmers. And also we promote Smokeless Chula under Ujjwala Yojana of Govt. of India. We create awareness among the rural communities and also provide the linkage which reduces the dependency on forest for the firewood. As electricity is a big issue in villages, we installed Solar Street lights in the village roads. Total 18 solar lights are installed in three villages of Kujanga block. The program covers total 26 villages in Odisha.



Sustainability has been the primary goal of Sambandh since its beginning. We are already aware of the catastrophic measures that the world is facing amid the crisis. If sustainability and proper measures are not learned, then we might face some unforeseen results. We being the learned citizens must spread the message



Vegetable cultivation by a tribal woman Kusumi is a married woman of Uttar village in Mayurbhanj. She has been a farmer all her life. Being from a tribal area it was difficult for her to address the various climatic challenge that she has been facing since years. Through the program of Asha, in collaboration with PPL and Edelgive, Sambandh has been able to exert various training sessions on climate change mitigation measures. It even includes how to develop proper measures to mitigate global warming and reducing carbon emission as well.

Kusumi has always been an ardent learner and therefore, she was able to apply all the knowledge that she has learned in the training sessions which has resulted in surplus crop production along with maintaining the sustainability as the primary goal.

ABHIPSA

Plantation with perennials to minimize greenhouse emissions

Funded by: NABARD

Area: THAKURMUNDA and KARANJIA

It is an initiative for the conversion of unutilized non-agricultural degraded land into horticultural orchard and are managed to minimize greenhouse emissions and maximize the sequestration of carbon in soils and vegetation which is good for environment and also it give some way of income generation. Majorly the Orchard comprises of Mango & Cashew Plantations which is a good source of income

This ensures livelihoods of 2700.No of Tribal Households through Orchard Development in 2500Acres degraded of Odisha.



As the program signifies that it is the conversion of unutilised degraded land into agricultural purposes. Funded by nabard , Sambandh has been able to provide employment along with taking care of the environment in a number of ways. Tha above beautiful scenery shows a farmer engaged in acutivatinga land which was degraded earlier . it is also a souce of income generation as many farmers who have very small land holdings are able to cultivate on large tracts of land thereby generating incomes for yhemselves . we also focus on encouraging farmers for mango and cashew cultivation , so that these foods provide for a larger income as they always remain on demand.

ABHINAV

Schools without walls for farmers

Funded by NABARD & KFW& Edelgive

Operational Area-Jashipur Block, Mayurbhanj

The aim of **ABHINAV** is to create a Farmer Field Schools; a group based adult learning approach to teach farmers on various farm and non-farm activities by asking questions and discussing their experiences. Extension and advisory services by Farmers' Field Schools (FFS) play a very important role in scaling up Climate Smart Agriculture (CSA). FFS contributes to the realization of all three objectives of CSA (food security, adaptation and mitigation), but are currently focused on the first of these, namely food security through enhanced productivity.

The school doesn't have any wall. It's not a classroom where the Facilitator speaks and the farmers simply listen rather, we have provided a platform to them where they can ask their doubts and questions which builds their experience and observation. And we encourage them to make their own decision and draw the conclusion.



Here in the left , you can see the glimpse of farmers gathering for a session on various developments that has been undertaken in agriculture. We can also see women farmers participation which is a way of empowering women and enhancing women participation in the decision making process.



Farmers school is a concept where all the food bearers come together for a learning related to their occupation. The very concept of farmers school has been very popular and has been proving resourceful because of thye very capacity to learn more on agriculture.

Here famers become aware of their work culture , they get to know the various benefits government is providing , they become aware of the various method nad technologies that might enhance their farming.

It is through the successful implementation of farmers field school by Sambandh that many cultivators have become well aware of the outside world and about the various developments made in farming.

ANWESHA

The living Laboratory-Knowledge center

Funded by: MHA & STRD, government of Odisha

ANWESHA focuses to build model knowledge centers to provide training on various aspects of livelihood governance, NRM and health along with field demonstrations on various agricultural practices and skill development. Sambandh has four centers in Odisha such as BBSR, Choudwar (Dist.-Cuttack), Thakurmunda and Jashipur (Dist.-Mayurbhanj) during last year we have been trained around 2243 nos. of local farmer, women and PRI representatives at our resource centers.

The knowledge hub

Funded by MHA & STRD , Gol , Sambandh has been successful in establishing a knowledge centre where training sessions are conducted on various issues such as health , on agricultural practices . such sessions has been fruitful in bringing a sense of social responsibility among people .

Such trainings are conducted with a dire motive of making every fellow citizen aware of his/her rights and as to what is a persons responsibility towards the other fellow citizen.

Many health camps are conducted and awareness programmes are done so that people become aware of the health aspects.

INTERNET SAATHI PROGRAM

digital literacy

Funded by: Google

We can see kalpana taking tutions to feed her family . she is an inspiration for Sambandh as her success story has inspired sambandh to work for many more women like kalpana . In accordance with the endeavor to spread to digital awareness, the Digital Literacy Training and Implementation project was lunched in Odisha by Google and Tata trust, FREND, which was implemented in 2019, where SAMBANDH was one of implementing partner in 4 costal districts of Odisha. Digital literacy training and implementation was a collaborative project with Google, Tata trust and FREND, implemented by Sambandh as a pilot project in 4000 villages of 4 costal districts of Odisha, (Jagatsinghpur,Kendrapara,Baleswar and Bhadrak) which initiated in 1st May 2019. The key objective of this project was to eliminate gender digital inequality and equip rural women with digital skills in order to ensure participation of rural women in digital economy. This project was in a piloting way, where Sambandh is upscaling it in 4 costal districts with an outreach in 38 Blocks, 4000 revenue villages in 4 costal Districts of Odisha, having total of 1143 internet



sathis in order to make 837,300 women aware internet benefits enhancing their overall quality of life.

A 20 year girl namely Kalpana Bal resides in a village named Bankapatna, which comes under the Simulia Block of Balasore District, Odisha. It's almost 30kms away from Balasore town. Her family comprises of 6nos of members i.e. herself, her Grandmother, father, Mother and two brother. Her main source of income is through give teaching tutions to nearby children's. She is visually disabled and she had studied up to intermediate level. She had to struggle a lot in maintaining her family. Seeing the hurdles of the family her father went to work outside in a company. On the other hand, she used to give tutions to the village children's. Now she has simultaneously been working for Internet Saathi. Till date she has been looking after 4nos. of villages namely Bankapatna, Bedpur Kabirpur & Naranpur which come under digital literacy project and she is earning well for her dreams .



Case study 3

Case study of Internet Saathi- 3

Name of the internet Sathi-Surasmita Pradhan.Age-21 years

Family member-6(Father, Mother, 1 & 2 sister and brother)

Location:Village-Arjuni, Block-Jaleswar, Dist-Balasore,odisha

Impact-They were highly benefitted in many sides and can stay updated with the modern world

Challenges Faced-I had to face many hardly while making the illiterate people learn about internet as well smart phone .Women of rural areas well totally un were of this kind of gadgets and thinks that this kind of stuff won't help them in any way.

I am 21 years old girl namely Surasmita Pradhan resides in a village name Arjuni which comes under in Jaleswar block of Balasore District Odisha. It is almost 60 kms away from Balasore town. My family comprises of 6 members, i.e. myself, my father, mother, and 2 sisters and 1 brother. My main source of income is through teaching dance to kindergartners in my village and other villages which are near to my village to and tailoring. My qualification is up to metric (10th).

My father works as a farmer and my mother is a housewife. Now I am working for internet sathi. Till date I have been looking after 3 villages namely Nachhimpur, Saharapara, Beli Gopinathpur which are under district literacy project.

I signified that I had learnt a lot and benefited from this internet sathi digital literacy project. Now I know how to use a smart phone and how to surf the internet and usage of Google as well as YouTube. I also mentioned that I had never even thought of handling a smart phone. But this project made my dreams come true. Besides this I had 130 women and the smart phone how to handle it a smart phone.

I have made them learn how to surf the internet and how to search things. The benefits I got from internet sathi can be signified below.

1. Online shopping and viewing necessary requirements
2. Dance choreography through YouTube
3. Online communication etc
4. For seeing exam results and jobs

Some benefits in my income are mentioned below

Support: It helped me a lot in my income too. I could view all the mandatory choreography required in my dance and could learn something and teach to children.

2. Voice search- This feature had helped me a lot to those who don't know how to read or write.

Nowadays I have become a self-dependent human because of the digital literacy project. Even my income has risen then before and now I am very happy in my present life.
